B.Tech (Handloom & Textile Technology)

1. Eligibility criteria considered for preparation of merit list.

B.Sc. students = Mathematics subject of study: B.Sc. candidates who have taken Mathematics at +2 level or studied Mathematics as Core or Ancillary subjects at B.Sc level alone are eligible for admission to BE/B.Tech Degree course through lateral entry.

3. **Nativity**

- Candidates who have passed **IX, X and Diploma** (or) **XI, XII and B.Sc. Degree** from respective state are eligible to apply.
- Candidates who have passed the above exam in the respective state need not enclose the Nativity Certificate.
- Native candidates who have passed any of the above exam or their equivalent examination from schools/College situated outside their state can also apply. They should enclose a copy of Nativity Certificate.
- Nativity certificate should bear the clause **“is native of”**. Certificates issued with clause “is residing at” without the clause “is native of” will not be considered
