GENERAL NOTES TO THE APPLICANTS

B.Tech (Handloom & Textile Technology)

Qualifying Examinations and Eligibility

Minimum Eligibility Marks as per G.O (M/s) No 34 of Higher Education(J2) Department dated 26.02.2019 is a pass in the HSC/Academic or its equivalent) with a minimum average percentage of 45% in Mathematics, Physics and Chemistry put together.

Note : When the candidate produce grade certificate, they have to provide the actual marks also otherwise only the minimum marks applicable to the grades in the eligible subjects (Mathematics, Physics, Chemistry will be taken into account).

Mode of Selection

The selection of candidates will be based on the marks obtained in the JEE (Main) examination. The community wise rank will be considered for allotment of seats. However if seats under any Community falls vacant, the same will be filled on Common Rank List (CRL) of JEE Main.

Nativity

- ❖ Candidates who have passed VIII, IX, X, XI & XII examinations from any States/Union Territories other than Tamilnadu are eligible to apply.
- ❖ Candidates who have passed the above exam in the State other than Tamilnadu need not enclose the Nativity Certificate.
- ❖ Native candidates of any State/Union Territory other than Tamilnadu who have passed any of the above exam or their equivalent examination from schools situated in Tamilnadu can also apply. They should enclose a copy of Nativity Certificate to claim that they are native of a State/Union Territory other than Tamilnadu.
- ❖ Nativity certificate should bear the clause “**is native of**”. Certificate issued with clause “is residing at” without the clause “is native of” will not be considered.
